The meeting information was posted on the website & Sunshine Law is in effect. Meeting open to the public. President Cohen asked for motion to open meeting to the public. J. Landzberg made the motion. J. Jacobson seconded the motion. All in favor.

President Cohen asked for a motion to approve the May 2025 minutes. J. Landzberg made a motion to approve the minutes and J. Jacobson seconded it. The minutes were approved on a roll call vote. The minutes will be posted on Borough website.

President Cohen informed the Board that an inquiry was received regarding Montvale's ear piercing and body art regulations. After reviewing the municipal code book, it was determined that the Borough does not currently have an ordinance regulating body art. S. Salerno suggested to include microblading, along with tattooing and piercing in the definition of body art in the ordinance. President Cohen said that the Borough Administrator is in favor of the creation of the ordinance and will have a first draft for the Board to review for the September meeting. President Cohen asked for a motion stating that the Board of Health is in support of the creation of a body art ordinance. P. Lennon made the motion. J. Landzberg seconded the motion. All in favor.

President Cohen informed the Board that she received a copy of the use permit for LaserAway Medical Spa from the Montvale Planning Board. The Board compiled a list of questions for the Board of Health secretary to present to the applicant.

President Cohen confirmed the date for the 2025 rabies clinic. The rabies clinic is scheduled for Saturday, November 1, 2025 from 9:30am-11am.

President Cohen informed the Board that she spoke with the nurse from Northwest Bergen Regional Health Commission regarding the date of the 2025 flu clinic. It is scheduled for Thursday, October 2, 2025 from 9:30am -11:30am. It was brought up by several board members that Yom Kippur lands on the same date and could limit the numbers of seniors able to attend the clinic. S. Salerno will reach out to the N. Reddy and the nurses organizing the clinic for another date.
